GUS ALEX, AKA., AR. DAILY SUMMARY. CG 6443-C ADVISED THAT HE LEARNED ON JULY 23 LAST THAT LES KRUSE, ASSOCIATE OF ALEX, WAS NOT GOING TO LEAVE THE CHICAGO AREA FOR HIS INTENDED TRIP TO LAS VEGAS, NEVADA. HE STATED THAT KRUSE WAS AT THE J AND J PICNIC GROVE GAMBLING CASINO, WILL COUNTY, ILLINOIS, FOR TWO HOURS ON JULY 22 LAST. HE ADVISED THAT HE LEARNED FROM KRUSE THAT JOHN DREW, REPRESENTATIVE OF GUS ALEX AT LAS VEGAS, NEVADA, WAS IN CHICAGO OVER THE WEEKEND OF JULY 22 LAST TO SEE ALEX. HE SAID THAT HE BELIEVED THAT DREW ALSO VISITED THE SUMMER HOME OF LOUIS BRIATTA, LOCATED AT GRAND HAVEN, MICHIGAN. HE SAID HE LEARNED FROM GUS LIEBE ON JULY 23 LAST THAT A FEW OF THE HIGHER ECHELON HOODLUMS OF THE CHICAGO AREA, WHO MAY BE SERVED SUBPOENAS IN CONNECTION WITH GAMBLING INVESTIGATIONS BY THE GRAND JURY AND BY THE MC CLELLAN COMMITTEE, MAY GO TO MERCER, WISCONSIN TO ENGAGE IN FISHING WITH RALPH CAPONE, WHO HAS A SUMMER HOME IN MERCER. ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
