GUS ALEX, AKA, AR. DAILY SUMMARY. CG 6443-C ADVISED THAT STEVE TOMARES, A CHICAGO JEWEL THIEF, HAS OWED INFORMANT \$5,000 FOR THE PAST SEVERAL YEARS. INFORMANT RECENTLY DISCUSSED THIS DEBT OF TOMARES WITH LES KRUSE, WHO OPERATED THE J AND J PICNIC GROVE GAMBLING OPERATION IN WILL COUNTY, ILLINOIS. THE PURPOSE OF DISCUSSING THIS MATTER WITH KRUSE WAS TO OBTAIN KRUSE'S INFLUENCE TO COLLECT THIS DEBT. KRUSE TOLD INFORMANT THAT HE WOULD HAVE TOMARES CONTACTED AND ORDERED TO PAY THIS DEBT TO INFORMANT IN THE NEAR FUTURE. KRUSE TOLD INFORMANT HE WOULD TALK TO GUS ALEX ABOUT THIS MATTER AND IF TOMARES DID NOT PAY THIS DEBT TOMARES WOULD LOSE THE SUPPORT OF ALEX. ALEX SHOULD BE CONSIDERED ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
