On 9/15/67, an effort was made to interview PHYLLIS MC GUIRE by SA M. B. PARKER and SA JAMES E. DOYLE at the new MC GUIRE residence. The maid informed that MC GUIRE had just awaken and was not dressed. The maid was instructed to contact MC GUIRE to see when she would be available for an interview. The maid returned and stated MC GUIRE had told her to take the names of the agents and she would contact the office to set up an interview. The agents returned directly to the office, and MC GUIRE telephonically contacted the Las Vegas Office within thirty minutes. Following a telephone conversation with SA PARKER, she declined to be interviewed in person and the conversation was terminated.

LV 241-C-TE is extremely close to DAVIS and MC GUIRE and has occasions to visit her residence frequently. Informant has advised that he has never seen subject in MC GUIRE's residence, and in informant's opinion, it is extremely doubtful that he would ever come to Las Vegas. U.

PHYLLIS MC GUIRE is currently playing as a single at the Riviera Hotel in Las Vegas. LV 361-PC advised on 9/25/68 that MIKE DAVIS was in town and was residing with MC GUIRE at her home. Informant further stated that DAVIS had bought MC GUIRE a \$35,000 custom-made Rolls Royce automobile which he had delivered to MC GUIRE on that date.

Periodic checks are made of MC GUIRE's residence by the Las Vegas Division. From a check of automobiles, it appears MC GUIRE is utilizing the services of a maid named BESSIE MC NEAL, whom MC GUIRE has utilized for a number of years when she would be appearing in Las Vegas prior to her moving here. Following MC GUIRE's appearance at the Desert Inn Hotel with her sisters in 1961, MC NEAL was interviewed and while she was not belligerent, she was definitely not cooperative. She gave the impression during the interview that she was completely loyal to MC GUIRE in every respect.)
