TECIP". UReferenced Bureau letter advised that following information concerning GIANCANA, as furnished by NY 4008-C-TE, should be submitted to Bureau file in captioned case. It is to be noted that this information was furnished Chicago under captioned matter by NY letter to Chicago, 8/12/68. UOn 7/29/68, NY 4008-C-TE advised that it had been learned that ~~SAM~~ GIANCANA receives approximately \$2,000.00 quarterly in dividends from stocks held in the General Foods Corporation. Source stated that the dividend checks are made out to a Mr. M. ~~LAPIDATIOUS~~ (ph), who resides in Beverly Hills, California. Source was unable at that time to determine whether or not this name was used by GIANCANA or if there was actually an individual with such a name fronting for GIANCANA. U
