GUERRA advised on several occasions that he had in his possession long distance toll charges for the telephone at Nubes No. 2. He promised on various occasions in person and by telephone that these would be available, but to date has not produced them

He also indicated that SANCHEZ had addresses in Acapulco of interest in this matter, but has failed to produce them.

It is becoming more and more apparent that GUERRA is not developing as a reliable source
