AS BUREAU AWARE, CURRENT STATUS OF INVESTIGATION OF  
GIANCANA THROUGH LEGAT, MEXICO CITY, INDICATES THAT WHEREAS  
GIANCANA APPARENTLY CONTINUES TO MAINTAIN RESIDENCE IN CUERNAVACA,  
MEXICO, AND TO RESIDE THERE ON SEMI-PERMANENT BASIS, IT WOULD  
APPEAR HE IS ABSENT FROM THIS RESIDENCE OCCASIONALLY. HOWEVER,  
HE HAS NOT BEEN KNOWN TO RETURN TO U.S.

AS BUREAU ALSO AWARE, CHICAGO OFFICE HAS BEEN IN RECENT  
CONTACT WITH FORMER CG SIX SIX FIVE SIX-PC, WHO HAS BEEN  
CONVICTED OF FRAUD BY WIRE VIOLATION AND IS CURRENTLY CONFINED  
COOK COUNTY JAIL AWAITING TRANSFER TO FEDERAL PENITENTIARY.  
NOTED PREVIOUS INVESTIGATION IN GIANCANA CASE DETERMINED CLOSE  
RELATIONSHIP ON PART OF FORMER PC AND GIANCANA.
