LA 5173-PC advised on 11/3/69, that he understands that DALE ROBERTSON, television and movie personality, 10801 Winnetka in the San Fernando Valley, telephone number 360-4947, has loaned SAM GIANCANA. one million dollars. Informant advised that it is his understanding that GIANCANA contacted ROBERTSON, and through a paper transaction, it appears to be a loan of one million dollars from ROBERTSON to GIANCANA, but the facts actually are that GIANCANA merely wanted to "cool" this amount of money, and ROBERTSON did not put up anything. Informant continued that the purpose of this, loan was for GIANCANA to be able to show the one million dollars as a loan from ROBERTSON.
