During early 1/70 subject reportedly was staying with a girl friend, a chorus girl from the Copacabana in New York, named JANE or JUNE H.

On 2/4/70 source said that subject's visitor reportedly came to Mexico as a regular traveler but using a different name before Christmas of 1969. They continued to speculate that the visitor was SINATRA.

On 2/5/70 FRANK BRANDSTEDTER (protect by request), prominent Acapulco hotelman who has acted as a source of this office in the past and is familiar with SINATRA, advised that local reports are that SINATRA is due in Acapulco 2/7/70. He is to take up residence in his home in the Las Brisas section.

BRANDSTEDTER will be alert for the possibility of subject being in contact with SINATRA or MOE MORTON in Acapulco.

MEX 34 advised 1/6/70 that telephone number 20836 in Acapulco corresponds to the Acapulco Towers located in Lomas del Mar above the Villa Vera Hotel.
