Re Bureau telephone calls from Bureau Supervisor
TOM McANDREWS, 10/25/64 and 10/26/64.

Referenced call reflected inquiry made of the
Bureau concerning the allegation made by E. BENNETT WILLIAMS,
Washington, D. C. attorney, to the effect that FBI Agents in
Miami were surveilling and harassing WILLIAMS and his client,
ALDERISIO, on the night of 10/24/64.

For the information of the Bureau, by communication
captioned "NY 2151-C," dated 10/13/64, the New York Office ad-
vised the Miami Division as follows:

"On 10/6/64, NY 2151-C overheard that there was to
be some type of a meeting of members of the organized Italian
criminal element, which meeting will be held in Randazzo's (PH)
Restaurant, Miami Beach or Miami, Florida. It was the infor-
mant's understanding that the restaurant could be identified
by a large sign affixed to the building. This meeting was to
be either held in this place on the 24th or during the week
of 10/24/64. The informant did not know how many people were
to be at this meeting, but that it allegedly is an important
meeting of SANTOS TRAFICANTE and other individuals closely
aligned with him."
