On 10/30/67, TP 120-C advised SA JOHN A. AMBLER that in a recent conversation between TRAFFICANTE and his long time close associate, JAMES COSTA LONGO, the two were heard discussing the appearance of various individuals before a recently convened Federal Grand Jury in Tampa, at which time LONGO mentioned to TRAFFICANTE that SA's JOHN A. AMBLER and JOHN R. BRETT seemed to be the ones who had involved everybody and TRAFFICANTE called both men S-O-B's.
