PH 269-C contacted by BRUNO 2/22/61. BRUNO intends to go to Florida (Miami) 2/23 or 2/24/61, for two week period. Claims he is not worried about IRS having papers regarding cigarette business in Florida. BRUNO wants PH 269-C to furnish information on lead which BRUNO believes will be used for location of race track. 1960 Buick (Pennsylvania registration E26-025) observed parked in front BRUNO residence today.

Detective ENRICO CAPITELLA, Philadelphia Police Department, who brought BRUNO in for questioning 1/19/61, interviewed today, but furnished no new details. Said BRUNO thought questioning only to harass him and BRUNO will move from Philadelphia when daughter graduates Temple University in 18 months. He hates Philadelphia. Is going to establish cigarette vending machine business in Philadelphia under his true name and sell for profit when moving to Florida. Copies of photographs taken by Philadelphia Police Department 2/14/61, obtained and being duplicated to forward interested offices.

Bureau and Miami will be advised when BRUNO departs Philadelphia and Miami will be requested to ascertain contacts there.
