PH 514-C today advised PETE MARTIN, previously described, unable to make contact with BRUNO to ascertain BRUNO's interest in gambling operation proposed vicinity of Doykestown, Pa., as BRUNO out of city.

PH 540-C advised today Hotel 14, New York City, where BRUNO alleged to stay when visiting New York, owned by (FNU) YANSKY, whose brother, Philadelphia, known to informant. YANSKY probably would be cooperative if contacted.

Deputy Commissioner, Philadelphia Police Department, DAVID MALONE, today advised that ANGELO BRUNO would probably be arrested upon return to Philadelphia to ascertain if he is bringing any illegal contraband from Miami to Philadelphia.

Miami is requested to advise Philadelphia with as much notice as possible BRUNO's departure from Miami, noting that PH 591-C* on 3/14/61 advised BRUNO possibly returning to Philadelphia Palm Sunday.

New York, at Hotel 14, New York City, will ascertain if BRUNO, under known name or aliases, registered at instant hotel, during last six month period, and contacts made there.
