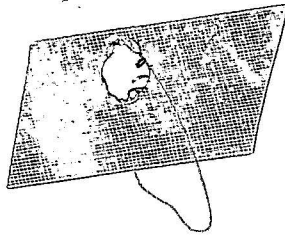

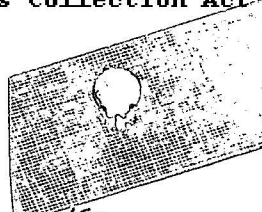

On 3/22/61, J. J. QUINN, Assistant Vice President, Broad Street Trust Company, advised ANGELO BRUNO had no account in bank but his wife SUE had an account. Related that in February 1961, BRUNO asked if it would be possible to deposit some funds he had obtained from sale of business in Miami to the account of his nephew MICHAEL GRASSO. BRUNO was interested in "controlling" account but was told that this was not possible as GRASSO had had reputation for kiting checks. Other banks checked for accounts with negative results.

PH 540-C furnished "key numbers" for auto of PHILIP TESTA, associate of BRUNO, for future possible use. Contents of car provided no information.

PH 591-C* stated PETER and MARIO MAGGIO had a brief conversation with person believed to be "SONNY" about contemplated gambling in New Jersey which ANGELO BRUNO apparently knows about and possibly would receive income from. Plans not formulated as yet.

Records obtained from BRUNO by Philadelphia Police Department 3/22/61 apparently consist of address book, copy of which being made available to Philadelphia probably on 3/27/61.
