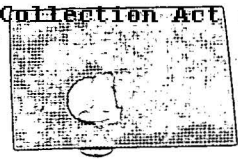

Re New Orleans airtel to the Bureau dated 8/16/61 with dual caption, "CARLOS MARCELLO, aka., AR; DELLA MC CUTCHEON, aka; JACK HAROLD HALFEN, aka, FUGITIVE; etal, ITSP, MASTER CHECK CASE" and re my let dated 9/14/61.

On 9/11/61, a photograph of JACK HAROLD HALFEN was exhibited to U. S. Consul PETER J. PETERSON, U. S. Embassy, Guatemala City, Guatemala.

At that time, PETERSON related that based on this photograph, HALFEN definitely is not identical with KENNETH GRAYSON PAXTON.

In addition, PETERSON related he has no further information regarding possible activities of PAXTON and BRAMLETT. He stated that should he receive any pertinent information in the future, he would advise.
