On 11/17/61 [redacted] (protect identity) OTHER 4 Foreign Assistant Head of Security, Special Investigations, Banco de Guatemala (Bank of Guatemala) Police, was contacted at Guatemala City. [redacted] advised he had caused a discreet investigation to be made in efforts to determine whether MARCELLO might have had some specific connection with KENNETH GRAYSON PAXTON and JOSEPH THERION BRAMLETT in the past. [redacted] related they had been unable to develop any pertinent information in that regard.

On 11/17/61 U. S. Consul PETER J. PETERSON, U. S. Embassy, Guatemala City, advised he has received no further pertinent information regarding this matter, nor any information regarding PAXTON or BRAMLETT's activities.

Inasmuch as inquiry in this matter in Guatemala thus far has failed to develop any information as to any specific connection between MARCELLO, PAXTON and BRAMLETT, and in the absence of any further request for investigation in Guatemala, this file is being RUC'd.

An extra copy of this communication is being furnished for the information of the Dallas Office in view of investigation conducted by that office in this matter in the past.
