Rerep of SA LEMAN L. STAFFORD, JR. dated 5/3/62 at Miami.

On 6/14/62, JOSE POLO, 117 Franklin St., Elizabeth, N. J., advised that he is the Secretary General of the New Jersey Delegation of the Montecristi Movement. However, he stated there are no meetings of this organization and he does not keep any membership rolls. Further he said that this organization is now defunct and does not exist. He stated this is due to the extreme state of disorganization and factionalism within the anti-CASTRO groups locally and he said for all practical purposes, the organization does not exist in New Jersey.

On 6/14/62, [redacted] Source of Information, Elizabeth, N. J., (protect by request) who is familiar with some phases of anti-CASTRO activities in the Elizabeth, N. J. area, advised that the Montecristi Movement is not functioning at this time in Elizabeth.
