GUS ALEX, AKA. AR. DAILY SUMMARY.

CG 6343-C\* ADVISED THAT ON JUNE 16, LAST, MAISH BAER VISITED CELANO'S TAILOR SHOP TO HAVE SOME SUITS ALTERED AND ENTERED INTO A DISCUSSION WITH JAMES CELANO CONCERNING HIS, CELANO'S, RECENT INTERVIEW WITH AGENTS OF THIS OFFICE. BAER TOLD CELANO "THOSE GUYS ARE NOT IN YOUR CORNER, THOSE GUYS WANT TO BURY YOU." BAER TOLD CELANO THAT HE SHOULD HAVE REFUSED TO TALK TO THEM AND SHOULD HAVE ORDERED THE AGENTS OUT OF HIS PLACE OF BUSINESS.

ACCORDING TO INFORMATION RECEIVED FROM CG 6443-C IN THE PAST BAER IS ALLEGED TO BE A BOOKMAKER FOR GUS ALEX AND IS SUPPOSED TO OPERATE HIS BOOKMAKING ACTIVITIES FROM THE H AND H RESTAURANT WITH FRANK ZIMMERMAN. THIS INFORMANT ALSO ADVISED THAT BAER IS ALLEGED TO BE ENGAGED IN THE JUICE RACKET.

BAER WAS INTERVIEWED BY AGENTS OF THIS OFFICE RECENTLY AND DENIED BEING ENGAGED IN ANY BOOKMAKING ACTIVITIES OR THAT HE HAD EVER BEEN ENGAGED IN THE JUICE RACKET. BAER DENIED THAT HE WAS ACQUAINTED WITH GUS ALEX OR ANY OF HIS ASSOCIATES. AT THIS SAME TIME ATTEMPTS WERE MADE TO INTERVIEW
