GUS ALEX, AKA, AR. DAILY SUMMARY.

CG 6443-C ADVISED THAT IN RECENT CONTACT WITH LESLIE KRUSE, KRUSE WAS VERY CONCERNED OVER THE FACT THAT PETER EPSTEEN AND HENRY SUSK, OWNERS OF AUTOMOBILE AGENCIES BEARING THEIR NAMES, AND FRIENDS OF ALEX AND OTHER CHICAGO HOODLUMS, WERE APPARENTLY IN SOME TYPE OF TROUBLE WITH THE ILLINOIS STATE TAX DIVISION. INFORMANT WAS OF THE OPINION THAT SINCE KRUSE WAS MAKING INQUIRY ON BEHALF OF EPSTEEN AND SUSK, KRUSE AS WELL AS ALEX, MAY HAVE A FINANCIAL INTEREST IN THESE TWO AUTO AGENCIES.

INFORMANT ADVISED THAT BOTH EPSTEEN AND SUSK WERE LOOKING FOR A FIX IN THE STATE AUDITOR'S OR A CONTACT WHICH WOULD ALLOW THE AUDITOR WHO EVENTUALLY WOULD GO OVER THEIR BOOKS TO OVERLOOK CERTAIN RECORDS THAT THEY WERE WORRIED ABOUT. INFORMANT SAID EPSTEEN AND SUSK WERE BOTH CHEATING ON THE AMOUNT OF SALES TAX FORWARDED THE STATE OF ILLINOIS IN CONNECTION WITH THEIR NEW CAR SALES. INFORMANT SAID THAT IN ORDER FOR THEM TO OPERATE FOR ANY LENGTH OF TIME, THEY WOULD HAVE TO MAKE A CONTACT IN THE ILLINOIS REVENUE DEPARTMENT AND PUT IN A FIX WITH EITHER TED ISSACS, CHIEF, OR CLEMENT SHAPIRO, DEPUTY CHIEF, OF THIS DEPARTMENT.

ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
