CG 6543-C-TE ADVISED THAT HE HAD RECENTLY DETERMINED THAT THE DEAL WHEREBY LOUIS ARGER, LIEUTENANT OF ALEX, WAS TO PURCHASE A 75% INTEREST IN THE CLUB ROUGE HAD FALLEN THROUGH. THIS INFORMANT HAD PREVIOUSLY ADVISED THAT ALEX WAS TO BUY INTO THE CLUB AND THAT JOE SMITH WAS TO KEEP A 25% INTEREST AND TO MANAGE THE CLUB ALONG WITH FRANK ZERAVICH, JR.

INFORMANT FURTHER ADVISED THAT WHILE HE WAS RECENTLY IN THE COMPANY OF LOUIS ARGER, ARGER WAS COMPLAINING ABOUT HAVING TO PAY TOO MUCH TO JIMMY ALLEGRETTI. INFORMANT DID NOT KNOW THE REASON FOR THE PAYMENTS TO ALLEGRETTI BUT ASSUMED THAT ALLEGRETTI WAS GETTING A CUT FROM THE PROFITS OF ARGER'S STRIP JOINTS ON SOUTH STATE STREET. INFORMATION HAS PREVIOUSLY BEEN RECEIVED AND REPORTED THAT ALEX GETS A CUT FROM ARGER'S ENTERPRISES ON SOUTH STATE STREET.

INFORMANT FURTHER ADVISED BILL FISHMAN OF THE CROSSROADS RESTAURANT WAS RECENTLY AT THE CLUB ROUGE AND MADE A STATEMENT THAT HE WOULD "DROP THE PAYROLL DOWN TO THE ROUGE" THE NEXT DAY. INFORMANT DID NOT KNOW IF THIS WAS A REGULAR PROCEDURE HANDLED BY FISHMAN AND IS ATTEMPTING TO SECURE FURTHER DETAILS IN THIS REGARD. INFORMANT STATED FISHMAN'S COMMENT INDICATED
