GUS ALEX, AKA. AR. DAILY SUMMARY.

RUDY DRODZ, FORMER PCI, ADVISED THIS DATE THAT HE HAD OBSERVED ALEX LEAVING THE BUILDING AT 188 WEST RANDOLPH STREET, YESTERDAY AT ABOUT 5:15 PM. HE SAID THAT HE CONTINUES TO SEE ALEX IN THIS BUILDING FREQUENTLY AND THAT ALEX VISITS POSTL'S HEALTH CLUB ON THE 27TH FLOOR OF THIS BUILDING.

CHARLES POSTL, PCI, ADVISED THIS DATE THAT ALEX WAS AT THE CLUB YESTERDAY AND THAT HE PERSONALLY GAVE HIM EXERCISES FOR ABOUT 20 MINUTES. HE SAID ALEX WAS AT THE CLUB THREE TIMES EACH WEEK AND HE GAVE HIM EXERCISES ON EACH OCCASION. HE SAID DOCTOR MARQUARDT, ALEX'S DOCTOR, CALLED HIM SOMETIME AGO AND ASKED HIM TO GIVE ALEX THE EXERCISES AND PERSONAL ATTENTION BECAUSE OF ALEX'S NERVOUS CONDITION. HE SAID THAT ALEX NOW DEPENDS ON HIM TO GIVE HIM HIS EXERCISES EACH TIME HE VISITS THE CLUB. HE SAID THAT ALEX IS STILL QUITE NERVOUS AND DOESN'T SAY MUCH.

CONCERNING THE OPERATION OF THE HEALTH CLUB, POSTL STATED THE CLUB IS IN OPERATION SIX DAYS A WEEK AND CLOSSES EACH OF THESE DAYS AT ABOUT 9 PM. HE SAID THAT HE HAS AN ELDERLY MAN STAYING AT THE CLUB ALL NIGHT, 5 NIGHTS A WEEK BUT NO ONE IS AT THE CLUB ON SATURDAY NIGHTS AND
