IN VIEW OF INFORMATION RECEIVED FROM CG 6502-C* THAT ALEX WAS FREQUENTING THE HARTFORD HOUSE RESTAURANT, THE GENERAL MANAGER, GEORGE N. SEELT, HAS BEEN INTERVIEWED ON TWO OCCASIONS. SEELT VERIFIED THE FACT THAT ALEX AND SOME OF HIS HOODLUM ASSOCIATES HAVE BEEN VISITING THE RESTAURANT FOR THE PAST SEVERAL MONTHS. SEELT IS OF THE OPINION THAT THESE ARE SOMETIMES SCHEDULED MEETINGS AND FEELS THAT BUSINESS IS DISCUSSED BY THEM AT THESE MEETINGS.

HE SAID THAT THE HOODLUMS CONTACT AT HARTFORD HOUSE IS JULES RIESER. AND THAT RIESER KNOWS THE IDENTITY OF ALEX AND HIS ASSOCIATES AND KEEPS HIM INFORMED WHENEVER THEY MEET AT THE RESTAURANT. SEELT SAID THAT WHENEVER ALEX OR HIS ASSOCIATES VISIT THE RESTAURANT, THEY ALWAYS OCCUPY ONE OF THREE BOOTHS IN THE REAR OF THE FRENCH ROOM.
