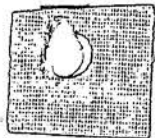

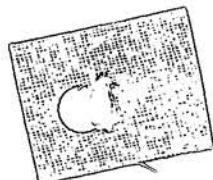

DL-149-C was recontacted by SA JOSEPH M. MYERS on 3/25/62 and he advised that shortly after WILL WILSON was elected Attorney General for the State of Texas, informant "heard" from several sources, two of whom he named as being W. M. "BOSTON" SMITH and WILBUR FRANCIS HICKS, aka. Bud Hicks, Fort Worth, Texas gamblers and from other sources around Fort Worth that WILSON had received money from Las Vegas gamblers, the names of which were not mentioned prior to WILSON's allegation. Informant stated that there was no way for him to prove this but that the information that he received was the common talk among the gambling circle in Fort Worth.

There is no indication in the files of the Dallas Division that the above information has been received from other sources and there is no data available which will confirm or disprove this allegation. For the information of the Las Vegas Office, information was developed at Fort Worth from DL-149-C who stated that he had heard that WILSON, Attorney General, State of Texas, had taken money from Las Vegas, Nev. gamblers at the time of his election to keep Texas closed up as far as gambling was concerned, thus forcing the Texas people to travel by air and other means to Las Vegas to do their gambling.

With reference to the hoodlum element in Denver, Colo. purchasing milk companies all over the United States, DL-149-C stated that he had received this information from [redacted] who resides in the Arlington Heights Section

of Fort Worth, Texas, and who was formerly from Kansas City, Mo. Informant stated that [redacted] married a distant relative of EUGENE SMALDONE of Denver, Colo. and [redacted] wife's relatives are still in Denver. Informant stated that he understood from [redacted] that his [redacted] were "big" in the Italian circle in Denver, Colo. and that she has an uncle in Danver, Colo. Informant stated that the reason he believes that [redacted] knows people in Denver was because at one time informant was having trouble in operation of his gambling establishment at Ft. Worth, because a Ft. Worth hoodlum, MARTIN BUSTER LOICANO, was trying to force informant into paying 25% of the take of his gambling establishment. Informant stated that he knew that [redacted] knew some Italian people in Denver and asked [redacted] to find out if LOICANO was connected with the mafia from these people in Denver. Informant stated that [redacted] who is not Italian, after having a few drinks, make a telephone call to someone in Denver and asked them if LOICANO was a member of the mafia, and according to informant, whoever was at the other end of the line "ate [redacted] out". [redacted] then told informant that he could not ever go back up to Denver. Informant stated that he would attempt to develop further information concerning this, however, if anyone questioned [redacted] at this time, it would "heat up" informant.
