

had propositioned a Dallas detective for a prostitution date. It had been determined she had recently come to Dallas from California but when interviewed had denied that the purpose of her trip was for prostitution. On 1/18/62 DL-83-C advised that the subject had been brought to CI by Dallas attorney JIMMY MARTIN and introduced on about 12/30/61. At that time subject had advised informant that she had contacted some prostitutes in California prior to leaving there about prostitution activities in Dallas and had been told to contact MARTIN who would introduce her to the right persons. She told CI that she had been working since her arrival in Dallas filling dates for \$50 to \$100 each but that business was slow. She further stated that she would work daytime call dates for \$25 per day. She furnished her phone number as FR 6-8720 but stated she was moving and would contact informant, furnishing new phone number. Informant was advised to obtain this information as soon as possible. information furnished to LT. REVILL and DEP. MORGAN on 1/18/62.

> Re: EDDIE TOM GREEN, aka. AR (DL 92-260)

On 1/15/62, SA BARRETT observed that GREEN's apartment was vacant and had a for rent sign on it. The landlord, LARRY E. SCAMMEL was immediately contacted and identified the subject as "Mr. WALLACE" who with his redheaded wife moved into the apartment on 11/15/61 but had moved out without notice on 1/13/62 owing \$50 rent. SCAMMEL stated that GREEN always paid his rent in \$100 bills but had no information as to where he had moved. There were several letters and circulars left in the apartment addressed to RAYMOND G. CLARK and also information that GREEN had obtained utility service under this name. On a piece of scratch paper furnished by SCAMMEL were 8 telephone numbers which are presently being checked and one of which is listed to Dallas top hoodlum JAMES HENRY DOLAN (DL 92-292). Neighbors also advise that GREEN had recently been driving the 1955 red and white Buick, Oklahoma 36-3488. They furnished information also that indicated one of GREEN's frequent visitors was DOLAN. It was noted one of the phone numbers found on the paper was TA 4-1954. On 1/19/62, SA MANNING C. CLEMENTS, while checking DOLAN's residence, observed a note on the door saying that "My new phone number is EX 8-7198 and I have only had it a few days" signed "Dave". A check of phone company records show that persons having EX 8-7198
