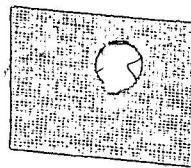
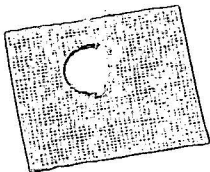

WEEKLY AIRTEL SUMMARY

Photographs of individuals in attendance at the wedding of SANTO JOSE TRAFFICANTE, subject's nephew, obtained and forwarded Bureau, as well as some films obtained at wedding reception, International Inn, Tampa, Florida, all on 1/19/63.

SA LIONEL E. BELANGER observed subject at wedding reception 1/19/63 where numerous relatives and long-time associates of the TRAFFICANTE family were also observed. No out of state licenses nor top hoodlums from out of town identified at reception except LOUIS P. BRADY. BRADY is subject of case entitled "LOUIS P. BRADY, aka. AR. OO: Chicago. Bufile 92-6008, Chicago file 92-1066."

In early morning hours of 1/20/63 TP 50-C advised subject was only in Tampa for wedding and was to return immediately to Miami, according to his brothers.

Subject has not been reported by sources and informants as being in Tampa since wedding reception.
