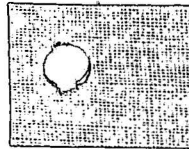
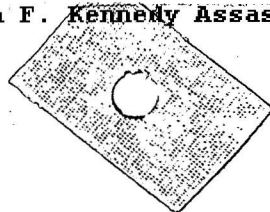

WEEKLY AIRTEL SUMMARY

Sources, PCIs nor CIs have reported subject's presence in Tampa.

Subject nor his wife observed 2505 Bristol, Tampa, Fla., residence, 10/22 - 26/62.

TP 41-C advised 10/25/62 he went to Miami past week and efforts to contact subject generally negative. Reported efforts to contact JIMMY DUCA negative inasmuch as DUCA allegedly playing golf everyday. Source was in contact with SIDNEY HOROWITZ, aka, Sid Howard, who claims he is now hanging around Miami Beach. Source reported HOROWITZ's girlfriend has Miami telephone FR 4-2906, but her name was not divulged to source.

HOROWITZ is individual who was observed driving Cadillac in past and visited subject's residence at 523 N.E. 71st St., Miami.

Miami note telephone call from residence of EVARISTO GARCIA VIDAL made to Lehigh, Fla. Then refer to case entitled JOHN JOSEPH BIELE, aka, AR (OO: Miami) Miami file 92-479, wherein it is noted Miami believed BIELE had some undisclosed interests in Lehigh Acres, east of Ft. Myers, Fla. and therefore, accelerate coverage of subject's activities.

Miami advise if suitable film clips have been obtained of subject and his Miami associates.
