Miami files reflect BERT K. NASTER, FBI #458 3572, was convicted in 1945 for Income Tax Evasion. He was accused in 1951 before a Congressional Committee of demanding \$500,000.00 from ABRAHAM TEITELBAUM, who "fixed" an income tax case against TEITELBAUM. NASTER later appeared before this committee and denied this charge.
