15. Remarks:

Bureau authority for the installation at TRAFFICANTE's residence was obtained telephonically on August 9, 1962, from the Bureau. The installation was made on the same date and placed in operation at 4:50 p.m., August 9, 1962. The installation consists of a MATE which is installed in the master bedroom of the TRAFFICANTE residence. It is noted that TRAFFICANTE formerly had a telephone in this bedroom which has since been disconnected. TRAFFICANTE and his wife apparently spend a great deal of time in the bedroom, as they have a television set in this room. It should be noted that installation of a MATE in another portion of the subject's residence was precluded at the time of installation for reasons of security.
