RAFAEL DIAZ BALART, source of information, who is in charge of the "White Robes", an antic Castro Organization telephonically advised the NYOPthet members of the July 26th Movement would picket International Airport on the afternoon of 1/22/60 when Spanish Ambassador JUAN PABLO de LOJENDIO would arrive enroute to Madrid, Spain after being asked to leave Cuba by FIDEL CASTRO.

It is the opinion of the NYO that PELLETIER, due to his close contact and association with FIDEL CASTRO, is not a political defecte of the Castro Government and that if he defects or leaves Cuba it is because of personal reasons rather than political reasons.
