Enclosed herewith for the Bureau are six copies of an LHM concerning captioned matter. Two copies are being designated for transmittal to Legat, Mexico. (Done)

Two copies are being furnished Miami and three to San Antonio in view of the fact they may be conducting active investigation in connection with individuals named in the title of this airtel. San Antonio should transmit one copy of the LHM to U. S. Customs, San Antonio, for their information.

One copy of this airtel and LHM are being furnished New York since Dallas Agents were furnished original information in this matter by NY 4003-C-TE.

Files of the Dallas Office reflect JAMES D. OWENS, the complainant in this matter, is the subject of a Federal Reserve Act - Conspiracy, Mail Fraud investigation being conducted by Dallas at the present time. OWENS is in the process of setting up a new company in Dallas known as the Eldorado International of Dallas, Room 723, Southland Center, Dallas. The office door indicates this company to be engaged in "Export-Import, Oil and Gas (Latin America), Public Relations, Foreign Analysis". OWENS is associated in this business with H. J. GOODFRIEND and HECTOR RANGEL. RANGEL is presently Mexican consulate at Dallas.

On 11/27/64, OWENS advised that J. D. Owens & Company, Inc. entered into an agreement with TIMOTHY DE JONG, Ace Research Company, 4934 East Timrod Street, Tucson, Arizona, whereby OWENS was to rent to DE JONG his personally owned aircraft, a 1962 Cessna Skyknight Twin 320, N5773X, SN 3200073, MNs R99247-1-B and L9925257-1-B. The plane was rented by DE JONG allegedly for the purpose of seeking out and finding certain treasures in Old Mexico. The contract stipulated the plane was to be used by DE JONG for a period of 30 days. The agreement was entered into on 10/19/64. When the plane was not returned on 11/19/64, OWENS contacted the Federal Aviation Agency (FAA) in an effort to determine whereabouts of the plane. When FAA was unable to furnish information concerning the plane, OWENS then thought the plane had been stolen and felt he should report the matter to the Dallas FBI Office.

On 11/27/64, after reporting the matter to the FBI, OWENS contacted SIDNEY SHINE, Empire Trading Corporation, 318 North Pearl, Dallas, who brought DE JONG to OWENS' office and introduced DE JONG to OWENS at the time the plane was rented. He told SHINE he had reported this matter to the FBI.
