MM 509-C on 12/26/62, advised that AL ROTH (Miami File 162-36) and IRVING SCHWARTZ, a bar operator and close friend of the hoodlum element, rented a store in the heart of downtown Miami, 135 E. Flagler St., equipped it with restaurant fixtures, and opened up under the name of Murfee's Bar and Restaurant. This restaurant is being supervised by MURPHY ROTH, a bookmaker and step-brother of AL ROTH.

He also advised that one of the women arrested by the Dade County Sheriff's Office in the raid of the Patio Bridge Club was CHARLOTTE FRANK ZION, wife of MICKER ZION, a bookmaker and gambler, as well as sister of BERNARD FRANK, a Miami Beach City Councilman. Also arrested in this raid on 12/13/62, was MILTON MICHAEL KALFA, a gambler and husband of the internationally known singer GRACIE BARRIE.

> TONY CORRADO, BILLY GIACALONE and ANTHONY ZERILLI, hoodlums from Detroit, Michigan, arrived in Miami via Delta Air Lines on 1/3/63. ZERILLI rented a Cadillac at the International Airport in Miami. It was learned the group registered into the Diplomat Hotel, Hallandale, Florida. CORRADO registered as Mr. and Mrs. A. J. CORTA of 677 Bishop, Bay City, Michigan; ZERILLI registered as Mr. and Mrs. TONY ZACK of 106 East Bay Drive, Bay City, Michigan; and GIACALONE registered as Mr. and Mrs. B. WILLIAMS, 1936 East Congress, Bay City, Michigan.

MM 730-C advised that on 12/18/62, RAY RYAN, a millionaire oil promoter and hotel owner as well as a big-time gambler, BEN/NOVACK, operator of the Fontainebleau Hotel, Miami Beach, Fla., MAX EDER (Miami File 92-467) and SAMMY SOKOL, a bookmaker, had lunch together at the Fontainebleau Hotel.

MARTIN DARDIS, Chief Investigator, Florida Attorney General's Office, Miami, on 1/3/63, advised they saw ALXDIETCH, a bookmaker and co-owner of the Cadillac Hotel Lounge, FIG Miami Beach, with SOLYEDER, brother of MAX EDER, take some bets. He said they hope to make an arrest here in the near future.
