He stated GREENFIELD, a shylock, and SAMMY WEISS, a shylock, as well as liquor store operators, have opened a new bar at Miami Beach and have named it the "Monkey Bar". He also reported that here of late JOSEPH INDELICATO (Miami file 92-404) has been meeting SILESI and WEISS daily at the Patio Bridge Club.

This source also advised that he was told that LOUIS CHESLER and his associates have in the recent past bet over a million dollars a year on horses and sporting events with MICHAEL COPPOLA (Miami file 92-101) and ALLIE HARRIS. Some of the bets were retained by COPPOLA and HARRIS, but the majority was laid off to other bookmakers and gamblers. He understood that recently some arrangement was made whereby REUBEN MILLER, now associated with MEL HARRIS (son of ALLIE HARRIS and son-in-law of CHESLER), in the Geller Building, Miami Beach, will receive all bets from CHESLER and his associates and then distribute the bets to numerous local bookmakers.

The President is HARRY LEVY and Vice President is EDWARD BLOCK of Miami Beach and Chicago, Ill. The Directors are HARRY LEVY; LILLIAN CONTE, a Miami Beach medical secretary; AMY HABER, executive secretary of Miami Beach Senior Citizens, and HANK TURK, who is in the chemical business. He understood this organization is advocating gambling casinos on a county option basis (with profits to be divided among Florida's 67 counties); off track betting; two lotteries a year, and restoration of bingo.
