MM 777-C furnished information that FRED VAN LENNEP, who married one of the Dodge daughters from Detroit and a very wealthy individual, will open the Pompano Trotting and Race Track, Pompano, Florida, this coming winter season. stated the track will be operated under the name of Tourist Attractions, Inc.; that VAN LENNEP would be President and the Board of Directors would consist of PERRINE PALMER, a hotel manager and political figure in Miami; MARION SIBLEY, a Miami attorney; JOHN WEIR, a Pompano attorney and real estate operator; and (FNU) MUSSELMAN, a Broward County, Florida attorney. This source further stated VAN LENNEP owns the Wolverine Trotters Track in the Detroit, Michigan area; is President of the Trotters Association there; is Vice-President of the National Trotters Association; has a horse farm at Lexington, Kentucky; and possesses homes in Chicago, Illinois, Columbus, Ohio, and Delray Beach, Florida.

MM 752-C advised that ANTHONY RUSSO (Miami 92-729), a member of the Racquet Club of North Bay Village, Florida, recommended ANTHONY DE SPIRITO, a jockey, and his wife to the Racquet Club for membership, but was turned down.

KEN SKATTEGARD, Investigator of the Florida Attorney General's Office, Miami, advised the Multiple Sports Service, Miami, operated by FRANK "LEFTY" ROSENTHAL (Miami 165-28) is the only firm in the Miami area, besides the regular news media, which has a ticker-tape operating.
