WEEKLY SUMMARY

MM 509-C-TE advised that he received information that MAX COURTNEY (MM 92-168) and FRANK "RED" REED, big New York City bookmakers and gamblers who visit Miami, Fla., during the winter season, were permitted by LOUIS CHESLER to buy some points in the Lucayan Beach Hotel Gambling Casino, at Freeport, Grand Bahama Islands, which is expected to be opened around the first part of 1964.

He also advised that RUBY LAZARUS, an underling of ANTHONY SALERNO (MM 92-406) flew to Las Vegas, Nev., on 8/20/63, for the purpose of acquiring some points in a Las Vegas gambling casino and returned to Miami on 9/2/63. According to word the informant received, LAZARUS stayed at the Desert Inn and had successfully acquired some points in the Riviera Hotel and Gambling Casino in Las Vegas for himself and ANTHONY SALERNO through a "front", whose name was not disclosed.

He related that LAZARUS, SALERNO, JERRY ZAROWITZ (MM 165-75) and NAT FARBER (MM 92-118) may move their bookmaking
