According to LEVY, if this group is not successful with the local authorities, they will take the matter to the Fla. Supreme Court.

Detective STEVE DI CIACCO, attached to the Intelligence Unit, Dade Co. 80, Miami, advised he received information that VINCENT JAMES PALMISANO (MM 92-503) recently disposed of his interest in Ciro's Restaurant and is now associated with Romeo's Pizza establishment located across the street from Ciro's Restaurant.

Detective BERT BERNSTEIN, attached to the Intelligence Whit of the Miami Beach Police Department, advised that THOMAS ALTAMURA (MM 92-410) is allegedly shylocking out of JIMMY D'ESTRO's Fur Shop, 939 Lincoln Rd., Miami Beach. He stated he accidentally ran across an office which D'Estro Fur Co. maintains in Room 206 of the Fashion Mart Building, Miami Beach, which is not listed on the building directory. BERNSTEIN stated there is a telephone in this office, UN 6-0179, and he suspects it may be a bookmaking office.

MM 665-C reported that he received information that another hotel is planned for Freeport, Grand Bahama Island; that it would cost in the neighborhood of 40 million dollars and that at least two of the principals are HARVEY SILVERT, a Los Angeles attorney who allegedly has some interest in Las Vegas, Nevada hotels and gambling casinos and a very wealthy Chinaman out of Hong Kong China, by the name of (FNU) KOO, who is a friend of HUEY YOUNG, a Miami Beach restaurant man (MM 162-275).
