GUS ALEX, AR. REBUCABLE JANUARY 14 LAST. BAVARIAN CRIMINAL POLICE ADVISED TODAY THAT ALEX'S RESERVATIONS AT BAYERISCHER HOF HOTEL, MUNICH, WERE CANCELLED ON JANUARY 12 LAST BY MUNICH OFFICE OF SWISSAIR. LOCAL AIRLINE OFFICE HAD BEEN INFORMED BY SWISSAIR IN NEW YORK THAT ALEX HAD BOOKED ON JANUARY 6 LAST FOR TRAVEL TO MUNICH VIA GENEVA AND ZURICH TO ARRIVE BAYERISCHER HOF, MUNICH, AT 4:55 PM JANUARY 17. SWISSAIR IN NEW YORK ISSUED CANCELLATION ORDER ON THIS FLIGHT TO AND HOTEL RESERVATION IN MUNICH ON JANUARY 11 LAST. NO FURTHER INFORMATION ON ALEX AVAILABLE IN MUNICH. GERMAN AND AUSTRIAN FEDERAL POLICE ARE ALERTED TO POSSIBLE ARRIVAL THIS AREA. IF REVISED BOOKING TO THIS AREA KNOWN, PLEASE ADVISE. PARIS ADVISED. RUC. *H*
