FROM LEGAT, BONN NO. 873

GUS ALEX, ANTI RACKETEERING. RE PARIS TELEPHONE CALL JANUARY 20 LAST. GERMAN FEDERAL CRIMINAL POLICE INFORM THAT ACCORDING TO BAVARIAN POLICE, ALEX HAD RESERVATIONS TO ARRIVE MUNICH FROM ZURICH ON JANUARY 20 LAST BUT THESE WERE CANCELLED AND WHEN ALEX DID NOT MAKE THIS TRIP FROM ZURICH ON THAT DATE, SWISSAIR IN MUNICH CANCELLED HIS RESERVATIONS AT THE BAYERISCHERHOF HOTEL FOR JANUARY 20. ALEX HAD NOT APPEARED AT THAT HOTEL UP UNTIL AFTERNOON OF JANUARY 23 AND NO INFORMATION DEVELOPED INDICATING HE HAS ARRIVED IN MUNICH. PARIS ADVISED.
