On 10/16/62, PCI [redacted] advised STOKES had not called him on Monday night (10/15/62) as per previous custom, but did call him early 10/16/62 and advised that from now on the line would be obtained sometime on Tuesday and would now be based on games played this year. On 10/17/62, PCI advised STOKES had contacted him night of 10/16/62 and told him that STOKES and his "backers" had had a difference of opinion and that the "backer" was now going to "get things done right". The "backer" told STOKES that he was going to have the parlay cards printed in Hurst from now on and therefore STOKES would not be needing JACKSON any further. STOKES was still to distribute the cards to customers at the Ling-Temco-Vought Corporation, Grand Prairie, Texas.
