He advised that he is certain that if he appears in Federal Court in Miami and is seen by ALDERISIO, his life as well as his family's will be in jeopardy. On 10/14/64, he advised that he called Mr. KENNEY, Departmental Attorney in Miami on the morning of 10/14/64 and pleaded with him, mostly on the basis that his absence will result in the ruination of his business; not because of his fear because he thought that would open up questions.
