AT MIAMI, FLORIDA

Will closely follow all phases of this case in order that it be ready for trial by 10/26/64.

INFORMANTS

Los Angeles airtel to Director dated 10/5/64, related LA 4410-C-TE has been unable to furnish any information of value for the past several months due to opening a new whodesale bakery and spending long hours at this work. It is possible he may be unable to continue as an informant and will probably have to be closed.

MORRIS LITBERG continues to reside at 2029 South Garth, Los Angeles, and his bakery operation is located at 1583 Colorado Eagle Rock, in the greater Los Angeles area. At both of these locations he is known as LEE TUTTLE.

The residence and employment of his son, HAROLD, is unknown. It is not believed advisable to ask him the whereabouts of his son at this time.

It is suggested that his residence only be given to KENNEY.

It is noted that LITBERG has indicated in the past in stray terms that he will not testify against ALDERISIO.

Re: TRIAL POSTPONEMENT

AT MIAMI, FLORIDA

On October 9, 1964, U. S. Attorney WILLIAM MEADOWS advised that he had that date received a telegraphic message from the Department of Justice, Washington, D. C., which requested him on the behalf of both prosecution and defense to request a one week postponement of the trial scheduled for October 20, 1964. Mr. MEADOWS stated Judge FULTON granted the one week postponement and placed the ALDERISIO-WERNER case at the end of his calendar for the week of October 26, 1964. As of October 9, 1964, Judge FULTON pointed out he already had four civil trials scheduled for the week of October 26, 1964, and therefore he could not be sure what day during the week of October 26, 1964, the trial of ALDERISIO and WERNER would commence.

Re: TRIAL PREPARATION AND INVESTIGATION

On September 25, 1964, Departmental Attorney KENNEY advised that he and Mr. MEADOWS expected to leave Miami on the night of September 28, 1964, and have an appointment to interview EGAN in Denver on September 29, 1964, at Mr. KENNEY requested that all FD-302s on interviews with EGAN, BRAY, KAY and BROOK be made available to the prosecutor since they expected that the defense attorney might invokee the Jencks * Rule and request these.

On October 9, 1964, original FD-302s on BRAY, EGAN, KAY and BROOK were made available to Departmental Attorney EDWARD HARRINGTON.

On October 5, 1964, a Xerox copy of the time log dated October 9, 1963, reporting the apprehension of ALDERISIO at Chicago by Bureau Agents was made available to U. S. Attorney WILLIAM MEADOWS per his request which was made to FBI Agents in Chicago on his recent visit there.

On October 5, 1964, the conference in Mr. MEADOWS' office participated in by Mr. MEADOWS, Departmental Attorneys WILLIAM KENNEY and EDWARD HARRINGTON and SA JOHN P. LENIHAN it was desired that other persons ALDERISIO had either threatened or beaten up would be subpoenaed and even if they refused to testify the effect they would have on any possible testimony from ALDERISIO or strategy used by the defense attorney might be effected. It was desired that MORRIS LITBERG and his son HAROLD of Los Angeles as well as the SEGAL brothers in New York

would probably be subpoenaed for this purpose.

On October 6, 1964, Mr. KENNEY advised that he did not have a current address for MORRIS and HAROLD LITBERG and he had telephonically requested the FBI Office in Los Angeles to forward the most recent available address of the LITBERGs to the FBI Office in Miami.

On October 7, 1964, Mr. KENNEY was advised that MORRIS LITBERG possibly resides at 2029 South Garth Street, Los Angeles, that he is generally known as LEE TUTTLE but the address of his son HAROLD is unknown.

AT LOS ANGELES, CALIFORNIA

MORRIS LITBERG advised on October 9, 1964, that he had not changed his mind about testifying against ALDERISIO. Under no circumstances will he do so, even if he has to go to jail for contempt of court. His reasons are the same: fear for the lives of his family and his own. He has good reason because he was beaten by ALDERISIO and others, five times and almost killed.

He also pointed out that his son, HAROLD, knew nothing about ALDERISIO and would be unable to testify to anything, even if he wanted to, which he does not.

He also stated that in addition to the above, one day away from his baking business, which is a one-man operation, would completely ruin him.

AT MIAMI, FLORIDA

On October 13, 1964, the above data provided by MORRIS LITBERG was made available to U. S. Attorney MEADOWS and Departmental Attorney KENNEY who advised they would take the matter under consideration.

AT NEW YORK CITY

Departmental Attorney WILLIAM KENNEY telephonically advised the New York Office that he intended to come to New York City on October 19, 1964, to interview SEYMOUR DANIEL SEGAL and ALLEN IRVING SEGAL.
