Re Miami cirtel 11/6/64 captioned "LA 4410-C-TE, Top Echelon Criminal Informant Program."

Remirtel requested that LA 4410-C-TE be reinterviewed for more specific information concerning the informant's knowledge of Miami hoodlum Anthony Ricci. It was also requested that all available information be obtained from the informant concerning his statement that, according to Ricci, Departmental attorney William Kenney was in the hip pocket of the hoodlums in Florida.

The interview with the informant should be conducted as expeditiously as possible. Submit results immediately by airtel.

NOTE: Rezirtel advised that informant was subpoensed to Miami to testify in the Felix Anthony Alderisio. Et Al, ITAR - Extortion case Informant had been instructed by his hoodlum associates in Los Angeles to contact Ricci for instructions concerning his interview with Departmental attorneys prior to his testimony. Ricci told informant that he would not be required to testify and that the case against Alderisio would probably result in an acquittal and that the Departmental attorney Kenney was in the hip pocket of the hoodlums. We are attempting to get additional details on the status of Ricci among the hoodlum element, in Florida, and specifically why Ricci considers Kenney to be in the hip pocket of the hoodlums.
