He is dressing conservatively and is using the name MIKE GENNATA (ph) or GENNETA (ph). MANOCCHIO is supposed to be associating with one JACK VONY (ph) from the New York area. This name is similar to the name JACAVONE which might be considered as a possible spelling of MANOCCHIO's associate. MANOCCHIO is supposed to be distributing counterfeit U.S. currenty with VONY. 1
