On 7/8/71, PC advised that PETER ~~BARILE~~, 425 New MAINE  
Boston Rd., Fall River, Mass., has been in contact with VEN- CONN.  
DITUOLI. PC advised that BARILE is telephonically contacted by VENDITUOLI, and meets him on occasion.

On 7/9/71, PC advised that BARILE met VENDITUOLI about a month ago at the Gateway Motor Inn, Portland, Maine.

On 7/12/71, PC advised that BARILE also has met VENDITUOLI at the Holiday Inn in Groton, Conn. in the past.

On 7/17/71, PC advised that if BARILE goes to meet VENDITUOLI, he will use his green 1970 Ford, Mass. tags 137-269B.

On 7/21/71, PC advised that ORLANDO ~~DE~~ MASS  
PETRIANO, MAINE  
(ph) aka "Connecticut Pete" has been in contact with BARILE, and one of them is going to meet VENDITUOLI shortly. PC advised that VENDITUOLI was due to call BARILE any day to arrange a meeting.
