MEADOWS SUGGESTED THAT ONE OF THE REASONS FOR WAITING UNTIL WEDNESDAY FOR PRESENTATION OF THIS MATTER TO GRAND JURY WOULD BE TO AFFORD MORALES AN OPPORTUNITY TO RECORD ADDITIONAL INCRIMINATING CONVERSATIONS WITH BOSCH AND OTHER CO-CONSPIRATORS BETWEEN NOW AND THE TIME OF THE GRAND JURY HEARING.

IN ADDITION, TESTIMONY BEFORE THE GRAND JURY WOULD BE TAKEN FROM [LOURDES CUESTA] WHO OVERHEARD A CONVERSATION IN A RESTUARANT IN WHICH BOSCH ADMITTED BEING INVOLVED IN THE SHELLING OF INSTANT VESSEL, AND THAT HIS GROUP WAS RESPONSIBLE FOR A SHIP BOMBING IN SAN JUAN, P. R. IT IS NOTED THAT THE SPANISH FREIGHTER QUOTE CROMOTO UNQUOTE HAD BEEN BOMBED AT P. R. SEVERAL DAYS PRIOR TO THIS CONVERSATION.

TESTIMONY WILL ALSO BE TAKEN FROM BUAGENTS CONCERNING SURVEILLANCES ON CO-CONSPIRATORS, AS WELL AS TESTIMONY CONCERNING THE OBTAINING OF PHYSICAL EVIDENCE SUCH AS THE BOMB WHICH HAD BEEN ATTACHED TO THE QUOTE LANCASTRIAN PRINCE UNQUOTE, AND THE RECOILESS RIFLE AND OTHER EVIDENCE OBTAINED IN INSTANT MATTER.
