WEEKLY SUMMARY

Fla PAUL DE LUCIA, aka. (MM 92-123) accompanied by GAETANO DE CHIARO, arrived at Miami International Airport, 11/16/63, from Chicago, Ill. ANTHONY RICCI, aka. (MM 92-112) met the plane in Miami and prior to the three leaving the airport, they were picked up by members of the Dade Co. Sheriff's Office Intelligence Squad and were taken to Sheriff's Office for questioning. Subsequently it was learned DE LUCIA was printed and photographed. DE LUCIA alleged he will remain for three or four days at the Thunderbird Motel, Dade Co., Fla. DE CHIARO claimed he was owner of P. M. Appliance Co., Franklin Park, Ill.

MM 673-C related he received information that one CY BLOOM, allegedly a close friend of BEN GAINES, operator of a Holiday Inn Motel at Coral Gables, Fla., contemplates opening a "steak house" restaurant on the site where Puccini's Restaurant, Miami, Fla. is located. The past two seasons Puccini's Restaurant was operated by JOSEPH FISCHETTI (MM 92-99) and his associates.

near MM 509-C-TE advised that George's Newsstand, Miami Beach, Fla., a hoodlum hangout, recently changed hands. He stated SANFORD LERNER and his wife, SHIRLEY LERNER, who acquired same, are as far as he has heard, legitimate business people. He pointed out that no bookmaking is taking place in the establishment at this time but that DAVE WASSERMAN, aka. "BLACKIE", takes the bookmaking action in the general vicinity.

He also reported that VINCENT ALO (MM 92-109) plays cards regularly at the Singapore Motel, Bal Harbour, Fla., with ~~MIKE WASELL~~, one of the owners, and others when ALO is in town.

Recently LARRY LORIA (MM 165-203) and BENNY ~~GREENBERG~~, bookmakers, were arrested by the Florida Attorney General's Office, Miami, Fla., for bookmaking at Loria's residence. MM 509-C-TE stated he learned that GREENBERG does not work for LORIA and just happened to stop at LORIA's residence to talk over some lay offs. He related GREENBERG is a sheet writer for ~~CHARLES KAUFMAN~~, a Miami Beach bookmaker. He also advised that he understood LORIA's son takes the telephone action for his father when LORIA is not there.
