MM 1124-PC has advised that GIANCANA has not been observed at the Fontainebleau Hotel or on the set of "Tony Rome", being filmed at Miami. SINATRA is still a guest at the Fontainebleau Hotel and is expected to remain in Miami area until approximately 5/17/67 when filming will probably be completed. *u*

DOMINIC "BUTCH" BLASI, former chauffeur of GIANCANA, was a guest of the Thunderbird Motel, Miami Beach, from 3/21/67 until 4/3/67 and CHARLES "CHUCKIE" ENGLISH, former golfing buddy of subject, was guest at the Thunderbird Motel from 3/19/67 until 4/2/67, when both presumably returned to Chicago. No information received that GIANCANA visited the Thunderbird Motel. *u*
