CG SEVEN ONE ZERO ZERO - PC, FORMER CLOSE ASSOCIATE OF GIANCANA, ADVISED HE WAS CONTACTED BY ONE OF DAUGHTERS OF GIANCANA TWO WEEKS AGO. DURING CONTACT DAUGHTER TOLD PC SHE HAS NOT SEEN GIANCANA SINCE HIS RELEASE FROM COOK COUNTY JAIL AND THAT GIANCANA HAS NOT BEEN "HOME" SINCE THAT TIME. STATED SHE IS UNAWARE OF HIS WHEREABOUTS AND THAT SHE HAS RECEIVED ONLY ONE PHONE CALL FROM HIM SINCE HIS RELEASE, THAT BEING LONG DISTANCE CALL FROM UNKNOWN LOCATION. *u*

PC, WHO IS CLOSE TO OTHER ASSOCIATES OF GIANCANA, SUCH AS ANTHONY ACCARDO, CHARLES ENGLISH AND PAUL RICCA, STATED TO HIS KNOWLEDGE GIANCANA HAS NOT RETURNED TO CHICAGO AREA SINCE HIS RELEASE AND REMAINS IN LATIN AMERICA. *u*
