On 5/22/67, the Direccion General de Seguridad (Directorate General of Security)(DGS), Spanish National Police, was requested to discreetly ascertain if the subject was in Mallorca, Spain, and if so, obtain all pertinent data regarding his activities while in Spain. (u)

(u) On 6/14/67, the Police Judiciaire (Criminal Police) Surete Nationale (PJSN) was requested for similar information regarding the subject who was reported to have been in the Nice, Cote d'Azur, France, area on approximately 5/14/67. (u)

On 6/19/67, the DGS advised that a discreet investigation conducted by their service in Palma de Mallorca, Spain, failed to reveal any information which would indicate that subject had been in Palma. The DGS further advised that in the event any pertinent information is received in the future by them, our office will be immediately advised. (u)

No reply has been received thus far from the PJSN. The Bureau will be advised of all pertinent information received by the Paris office regarding the subject. (u)
