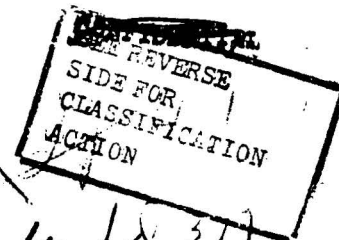

AUGUST ONE LAST. U

YOU SHOULD CONTINUE DISCREET EFFORTS TO POSITIVELY ESTABLISH SUBJECT'S PRESENCE AT CUERNAVACA ADDRESS THROUGH EXHIBITION OF HIS PHOTOGRAPH TO YOUR SOURCE AND BY OTHER MEANS AVAILABLE TO YOU. (A) U

IN CONNECTION WITH THIS MATTER, THERE IS NO DESIRE TO INTERFERE WITH NORMAL RESPONSIBILITY TO DISSEMINATE PERTINENT INFORMATION TO MEXICAN AUTHORITIES. HOWEVER, IF GIANCANA'S IDENTITY AND PRESENCE ARE POSITIVELY ESTABLISHED AND LEGAT DEEMS IT ADVISABLE TO DISSEMINATE, THE BUREAU SHOULD BE ADVISED BEFORE INFORMATION IS FURNISHED TO MEXICAN AUTHORITIES IN ORDER THAT INTERESTED OFFICES CAN BE ALERTED TO POSSIBILITY OF GIANCANA'S DEPARTURE FROM MEXICO AS A RESULT OF ACTION BY

CABLEGRAM TO LEGAT, MEXICO CITY

MEXICAN GOVERNMENT. BUREAU SHOULD ALSO BE ADVISED OF ACTION  
TO BE ANTICIPATED BY MEXICAN AUTHORITIES WHEN THEY ARE AWARE  
OF SUBJECT'S RESIDENCE IN CUERNAVACA. (X) (u)

NOTE:

Giancana, Chicago underworld leader, has been absent from Chicago area since his release from prison 5/31/66, and continuing efforts have been made to establish his whereabouts. Recent information developed by Legat, Mexico City, indicates he is probably residing in Cuernavaca, Mexico. Legat instructed to verify subject's presence in Cuernavaca through discreet inquiry in order to prevent disclosure of Bureau's interest and whereabouts. Legat has requested Mexican immigration authorities who have an interest in Giancana's activities to hold any further action to establish Giancana's presence in abeyance. Legat has advised that in view of the interest of the Mexican Government, he feels that if Giancana is located in Cuernavaca, it will be necessary, in the interest of preserving good working relations, to inform Mexican immigration authorities. He is being instructed to follow normal dissemination procedures, but to advise the Bureau in the event Giancana is located before disseminating to Mexican authorities in order that interested authorities can be alerted in the event Giancana is forced to leave Mexico.
