On 7/28/67, NY 4008-C-TE advised SAS NICHOLAS J. LORE and DONALD A. RIVERS that during a recent trip to Los Angeles and Las Vegas informant met one AARON "BUDDY" LAPIN. LAPIN is a wealthy businessman who has many connections in Las Vegas. He has made considerable money in the manufacture of components for aerosol spray cans. His most recent successful venture was the introduction of a device that heats shaving lather dispensed in aerosol cans. In this latter venture, subject is one of LAPIN's hidden partners. u

LAPIN has a brother, ZED LAPIN, who is well established in the Dunes Hotel, Las Vegas. When in New York, AARON LAPIN resides in the Hampshire House, Central Park South, New York City, N.Y. u "BUDDY"

NEVADA NY 4008-C-TE is documented as an individual who is acquainted with and has extensive contacts within the higher echelon of the gambling element in the US. u
