On 8/24/67 MEX-42 and MEX-196, reliable, Mexico City surveillance informants furnished the following information based on surveillances that date in Cuernavaca, Morelos, Mexico:

They observed a person they believe to be Subject at the house at Las Nubes 2 in the Rancho Tetela section of Cuernavaca at about 11:30 a.m. 8/24/67. He was observed leaving this house in a black 1964 Mercedes sedan with Morelos license 507 SY. He was seen with and without sun glasses and was identical to subject in physical appearance and both sources claim to have identified him by his photographs. He was wearing a gray hat with a black band and was smoking a cigar. He was accompanied by a female who appeared to be Mexican, in her forties, black hair, dark skin, not particularly attractive, and not believed identical to BERGIT CLARK.

Before leaving the vicinity the Mercedes made a slow tour of the neighborhood and driver appeared to be attempting to detect surveillances.

Also parked at the house at Nubes 2 was a gray Volkswagen, Morelos license RK 203, driven by a Mexican male who spoke with the Mexican female. He gave the appearance of possibly being a "pistolero", a local gunman or bodyguard. These are not uncommon in Morelos and are very dangerous men.
